**Illinois Terrorism Task Force (ITTF) – Full Meeting – April 23, 2014 – 1:00 p.m.**  
**Held at the Illinois Emergency Management Agency (IEMA)**

**ITTF Administrative Update**

Chairman Kauerauf acknowledged the membership's willingness to adjust the meeting schedule in order to discuss and vote on the FFY 14 State Homeland Security Grant Program (SHSGP) Program Application and Budget and the Capital Replacement Grant Program.

Chairman Kauerauf met with the Federal Emergency Management Agency (FEMA) and representatives from the National Preparedness Directorate to discuss and develop a FEMA case study on how homeland security monies are being effectively used and best practices that are being developed. One state (Illinois) per FEMA region was chosen to highlight programs and processes.

FEMA has notified us to anticipate receiving FFY 15 Grant Guidance on October 1, 2014.

**State Homeland Security Briefings**

Assistant Director Joe Klinger, Illinois Emergency Management Agency, provided a state homeland security update. He announced that the first-ever America's PrepareAthon!, sponsored by FEMA, took place on April 30, 2014. This is a new nationwide, community-based campaign to increase emergency preparedness and resilience through hazard-specific drills, group discussions and exercises conducted twice a year focusing on four specific hazards: floods, tornadoes, wildfires and hurricanes. He encouraged everyone to register on FEMA's website and participate.

On behalf of Director Monken, he expressed his appreciation to the chairs and membership for the countless hours of hard work and dedication on the FFY 14 grant process.

**Homeland Security Briefings**

Jay Stewart, Terrorism Research Specialist, Statewide Terrorism and Intelligence Center, Illinois State Police (ISP), provided a briefing on national intelligence trends.

**Old Business**

**FFY 2014 SHSP Grant Program Budget**

Chairman Kauerauf discussed the HSGP FY 14 grant award process.

Chairman Kauerauf provided an analysis of HSGP Funding: 1999-2014. He stressed how the threat, vulnerability and risk scores Illinois receives determine the amount awarded. He also discussed the ITTF funding patterns; grantees will no longer be able to continue to draw from multiple years of grants due to FEMA guidelines on grant extensions and the performance period of grants now being 24 months (instead of 36 months). For program and grant administration, ITTF will now analyze and determine what funds are needed on an annual basis (i.e. specific recurring maintenance, personnel costs, training, etc.). The current grant cycle (FFY 13) began on April 1, 2014, ending March 30, 2015. The FFY 14 budget and application that are being discussed and voted on today will begin April 1, 2015, ending on March 30, 2016.

Chairman Kauerauf discussed how the Illinois Homeland Security Strategic Plan and the outcomes of the Threat Hazard Identification and Risk Assessment (THIRA) provide input for the development of the 2014 grant application. He asked the committees to determine what priorities/projects within the Strategic Plan were essential for the development of the

grant application. Ultimately, these projects will support the implementation of National Core Capabilities and further Illinois' plan to address the outcomes of the statewide Vision 2020 summits.

Timeline:

- Applications Due: May 23, 2014
- Anticipated Award Date: No later than September 30, 2014
- Performance Period 24 months: Ending August 31, 2016
- 25% Law Enforcement Terrorism Prevention
- 80% local share of SHSP and UASI funds must be obligated within 45 days of award

At the March 26, 2014, ITTF committee chairs meeting, each committee presented their projects, and discussed and scored the FY 2014 SHSP project requests (43). ITTF staff compiled the results and provided to the Governor's Homeland Security Advisor for his review and approval. On April 16, 2014, each ITTF member received a summary of the FFY 14 recommended budget and a link to view all project proposals submitted by the committees. On April 21, 2014, each member was provided the opportunity to ask any questions about the proposed FFY 14 SHSP projects/application on a conference call with Chairman Kauerauf and Director Monken. Although not all projects were funded, all 43 projects will be submitted (if approved) in the grant application. If funding becomes available, these projects will be funded.

Each committee presented an overview of their project priorities that were approved by the Governor's Homeland Security Advisor.
