Homeland Security Updates

HSA/IEMA-OHS Director Tate-Nadeau clarified the roles of the HSAC and the newly established Office of Homeland Security. She also addressed the release last week of the White House's national cybersecurity implementation plan and the Microsoft hack.

Chairman Page introduced recently appointed Deputy Director of Homeland Security Claire Moravec.

Jennifer Rominger, Security Program Manager, Department of Innovation and Technology, provided a cybersecurity update.

Old Business

• SFY 24 PAR and Gaps Capital Replacement Projects Budgets – Chairman Page and Committee Chairs provided information on the projects included in these budgets.

Motion to approve budgets for the SFY 24 Preparedness and Response Grants and the Gaps Capital Replacement Projects.

• Prevention Committee Update – Prevention Committee Co-Chair Eric Arnold spoke about how the Prevention Committee grew out of the previously established School Safety Working Group

and the statewide targeted violence prevention initiative. Currently the committee's three main focus areas are crisis response, behavioral threat assessment/targeted violence prevention, and mental health services. Arnold also mentioned two grant opportunities. The University of Illinois Chicago is applying for one (focused on behavioral threat assessment/targeted violence prevention), and Peoria Regional Office of Education is applying for the other (to build up regional assets to help prevent targeted violence in schools/campuses). The grant recipients should be announced by October.

New Business

• Illinois Public Works Mutual Aid Network (IPWMAN) is requesting \$110,000 to be awarded to the Mutual Aid Box Alarm System (MABAS) as its fiduciary to support the position of Executive Director at IPWMAN to manage the homeland security preparedness and planning activities of the organization.

Chairman Page gave some background, explaining how IPWMAN is growing in membership and in requests for deployment. Thus far, IPWMAN has been self-sufficient/self-funding, but it has now reached a point where in order to enable continued growth and expansion statewide, IPWMAN is requesting funding for an Executive Director, who would be an employee of MABAS.

Motion to award \$110,000 through the FFY 21 Homeland Security Grant Program to the Mutual Aid Box Alarm System as fiduciary for the Illinois Public Works Mutual Aid Network to fund an Executive Director for IPWMAN.

- SFY 24 Gaps Report Timeline
 - Gaps Report Data Chairman Page stressed the importance of the "gaps" data, in concert with the accomplishments outlined in the HSAC Annual Report, to provide a complete picture to the governor's office and legislature as funding decisions are made. Page will be reaching out to individuals/organizations to start gathering that data.
 - Capital Replacement Budget Page said that previous capital replacement lists
 will be sent out, and he asked that organizations refresh/update the lists to reflect
 progress that has been made in equipment replacement and needs that still exist.
 - Unmet Needs List as in past years, this list is primarily made up of previously proposed projects (e.g., equipment replacement, training, etc.) that did not receive initial funding. As the grant cycle progresses and "leftover" funds become available, projects from this pre-approved prioritized list can be funded, saving time by not having to go back to the HSAC repeatedly for approval. According to the tentative timeline, the Council of Chairs will vote on the prioritization of unmet needs at the Sept. 27th Council of Chairs meeting.
 - At the full HSAC meeting on Oct. 25th, a final vote will be taken on the prioritization of unmet needs, capital replacement budget, and gaps report budget request.

- The decision was made to cancel the Aug. 23 Council of Chairs meeting because of its proximity to the IEMA-OHS Annual Training Summit, Sept. 5-8. A cancellation notice will be sent out.
- Chairman Page reported that the new Starcom contract has been signed. For several years, HSAC has paid user fees for 2,500 radios at a cost of \$250,000. Going forward, HSAC will only be paying fees for 1,400 radios. The Communications Committee will provide a proposal on how to best use the funds that are no longer needed for radio fees.
- Mandatory training requirements for HSAC appointees: Four online training courses are required annually for all voting appointees and alternates of HSAC member organizations. The due date is July 31. Chairman Page asked anyone with log in issues to contact him or Julie Pfeifer.
