### Call to Order

ITTF Chairman Jim Page greeted everyone and called the meeting to order. It was determined that a quorum was present.

### **Public Comments**

No members of the public were present.

### FFY23 HSGP Projects

Chairman Page introduced the meeting's only agenda item -- the discussion and approval of project submissions for the FFY23 Homeland Security Grant Program (HSGP) to present to the full task force on April 19.

Page explained how this year's HSGP funding amount is the same as for FFY22, plus there is a required minimum this year for election security. Requests this year totaled \$4.5 million more than available funding, so cuts had to be made. He thanked applicants for revising their requests to help reach the targeted amount. Page said it is hoped that many of the cuts from HSGP can be funded through the state Preparedness and Response (PAR) grant program.

Page presented his proposal as a starting point for discussion. Organizations offered feedback, input, and additional information on project requests.

Motion to approve FFY23 HSGP project submissions and recommend to the full ITTF.
