Homeland Security Updates

HSAC Chair Jim Page announced that some member organizations did not meet attendance requirements for 2023 (at least 50 percent of scheduled meetings) and that letters would be going out pending IEMA-OHS legal review. For individuals unable to complete their required 2023 annual training because of IT issues, paper versions will be made available.

Chief Intelligence Officer Aaron Kustermann, Illinois State Police State Terrorism and Intelligence Center, provided an intelligence briefing.

Deputy Chief Security Information Officer Dan Sluga, Illinois Department of Innovation and Technology, provided a cybersecurity briefing.

Old Business

- Chairman Page shared that a few committees still haven't submitted their information for the HSAC Annual Report due to the Governor's Office March 1. Page will reach out to those committees.
- Update on Unmet Needs List Projects Acting IEMA-OHS PGA Division Chief Bob Evans provided an update on the list that was approved by the HSAC in October 2023: to date over \$1 million has been pushed out for unmet needs projects from the list. As FFY 20 HSGP and SFY 24 PAR are both near their closing dates, organizations are asked for timelines to complete the projects. The sooner grantees can let IEMA know they will not be able to expend all funds by the deadline, the more unmet needs projects can be funded.

New Business

- Bob Evans reviewed the timeline for committee project submissions for the FFY 24 Homeland Security Grant Program (HSGP) and SFY 25 Preparedness and Response (PAR) Grant Program. He reported that a federal budget has not been passed yet and that there will be a condensed time frame to submit applications once the Notice of Funding Opportunity is issued (currently a tentative NOFO release date of March 22). National priorities are expected to be the same as last year. Attachment A's will be sent out to committee chairs this week, and committees should review current and potential new projects, with a focus on how they fit into the overall strategy. Attachment A's are due back by March 20. The Council of Chairs will review project submissions at their meeting on March 27. After that, focus will turn to SFY 25 PAR funds. A special Council of Chairs meeting is tentatively scheduled for April 17 to review the state application in advance of the April 24th full meeting, when the HSAC will vote on the submission to FEMA and go over PAR funding.
- Bob Evans clarified the use of grant funding for the new Illinois Paid Leave for All Workers Act for part-time or hourly staff paid by preparedness grants. According to FEMA, if an organization has part-time or hourly staff currently funded with federal preparedness grant funds, then those grant funds can be used to pay for up to one week of leave in accordance with the act.

• Vision 2028

- O Deputy Director of Homeland Security Claire Moravec discussed the collaboration process to develop Illinois' Homeland Security Strategy and gave an overview of its goals and objectives. She said Vision 2028 takes a "whole of state" approach to homeland security and reminded the HSAC that all projects recommended for funding must directly align with Vision 2028 goals.
- O Vision 2028 is due to the governor's office by Feb. 28

Motion to support Vision 2028 as presented with the caveat that last-minute modifications may occur prior to submission to the Governor's Office.
