Executive Summary

The Illinois Emergency Management Agency and Office of Homeland Security (IEMA-OHS) is committed to building a community of professionals prepared to meet current and future response and recovery objectives by providing the appropriate education and training opportunities. IEMA-OHS is committed to supporting local jurisdictions in meeting administrative requirements throughout the entire process from self-assessments through the conduct of exercises and AAR and Improvement Plan development.

IEMA-OHS Operations Training and Exercise Program is available to emergency managers statewide. This Program targets gaps identified by the Threats and Hazards Identification and Risk Assessment, Stakeholder Preparedness Review, and the Illinois Capability Assessment THIRA Tool analysis. Nested within Homeland Security Exercise and Evaluation Program principles the Integrated Preparedness Program development follows a process aligned with an accreditation program, managed by a committee to review AAR/IP corrective action items, Training and Exercise priorities, Training and Exercise Challenges, and current/intelligence-driven events.

IEMA-OHS's training philosophy dictates that certifications and exercises require that the target audience demonstrate proficiency. This allows for a true understanding of where state-wide capability gaps exist. Quality exercises take significant time and resources to develop, therefore, the Multi-Year Strategic Preparedness Plan follows a series of overlapping three-year cycles: Discussions-Based, Operational Based, and Full-Scale Exercises. The success of this cycle is dependent upon attention to planning, individual training, and discussion-based exercises during year one. To achieve this, we are partnering with a consortium of trainers to capitalize on the expertise throughout the emergency management/first responder community and coordinate efforts to eliminate redundancy. Additionally, the team has developed ready-made exercise tool kits and identified the associated core capabilities they cover to lessen the planning burden on the local emergency managers.

In conclusion, IEMA-OHS is dedicated to improving the readiness of Emergency Management professionals and the profession overall. By partnering with our stakeholders and offering specialized training opportunities, the agency ensures that emergency managers statewide possess the required skills and expertise to effectively confront a dynamic array of threats and hazards. This strategic IPP reflects the careful orchestration of discussion-based, operational, and full-scale exercises, emphasizing the pivotal role of planning and collaboration. In this integrated plan, IEMA-OHS remains resolute in nurturing a culture of preparedness that bolsters community resilience and upholds collective security.

Introduction

Purpose

The IEMA-OHS Training and Exercise Program follows the guidance found in FEMA's Homeland Security Exercise and Evaluation Program, which provides for a consistent, fundamental approach toward exercise programs that allows for a set of common principles to be applied toward exercise program management, design, development, conduct, evaluation, and improvement planning. This core set of principles is key to establishing and maintaining a robust training and exercise program.

The IEMA-OHS Training and Exercise Program supports a multi-echelon, whole-community approach to preparedness to better prevent, prepare for, respond to, mitigate, and recover from all threats and hazards facing the state and Illinois communities.

Together, through strategic and coordinated efforts on the part of local jurisdictions, state agencies, partner agencies and organizations, private industry, federal partners, IEMA-OHS staff are comprehensively identifying local and state threat and hazard vulnerabilities, capability gaps, resource needs, and mutual aid availability and creating a snapshot of preparedness. This multilayer relationship pays dividends both in relationship-building among partners, as well as in the integral coordination of training and exercise plan development.

This document, consisting of the IPP and supporting Training and Exercise Program Annexes will demonstrate how the Training and Exercise Program achieves its mission for a multi-echelon, whole-community approach to preparedness, adhering to HSEEP guidance and focusing on meaningful, strategic capability-building and maintenance priorities.

Applicability and Scope

The HSEEP doctrine is flexible, adaptable, and available to use by all jurisdictions, regardless of whether they use the Core Capabilities¹ as outlined in the National Preparedness Goal².

Integrated Preparedness Plan

Preface

The EMPG, administered through FEMA, requires recipients to engage senior leaders and the whole community to identify preparedness priorities specific to training and exercise and the development of a multi-year IPP. Additionally, all recipients are required to develop and maintain a progressive exercise plan that is consistent with HSEEP guidance in support of the National Exercise Program.

Similarly, a training program should be developed to align with the multi-year IPP. All EMPG-funded personnel are expected to be trained emergency managers and to complete the required coursework.

Administered by IEMA-OHS, the state Training and Exercise Program coordinates with local jurisdictions, counties, state agencies, federal, private, and non-governmental partners to develop and distribute the multi-year IPP. This plan represents projected preparedness activities for all stakeholders based on their jurisdictional capability needs. Each activity is focused on building, sustaining, or reinforcing FEMA Core Capabilities through training that bridges a knowledge gap and exercises that build, test, or validate plans.

Purpose

The purpose of the State of Illinois Multi-Year IPP is to prepare an all-hazards training and exercise agenda. This encourages a strategic approach for addressing and integrating planning, training, and exercise needs necessary to build and sustain capabilities. The IPP is a 3-year plan and incorporates planning, training, and exercise priorities for all local accredited jurisdictions, state agencies, non-governmental organizations, mutual aid partners, and private partners. This allows opportunities for calendar synchronization among



participants, which increases collaboration and coordination efforts, as well as efficiency in resource management. This plan is the keystone to achieving the goals and objectives of IEMA-OHS's Training and Exercise Program.

The multi-year IPP fulfills training and exercise requirements in accordance with 29 Illinois Administrative Code 301, as amended. The IPP is considered a living document that is reviewed and published semi-annually and refined as necessary throughout the year.

Included in this multi-year IPP are training and exercise tables which provide a schedule of the proposed training and exercises for years 2024 through 2026 and beyond when available.

Scope

The scope of this plan applies to the whole community within the Illinois Emergency Management community. Planning efforts include and are not limited to state agencies, local jurisdictions, mutual aid partners, private industry, and non-governmental organizations. This inclusive IPP is a functional planning document designed to build and sustain capabilities at all levels. Throughout the integrated preparedness planning process, it is critical for all stakeholders, to be a part of the data collection and analysis process; jurisdictional capability prioritization; multi-year IPP development, and training and exercise delivery.

State Training and Exercise Program Goals and Objectives

The Training and Exercise Programs share a common goal: to prepare the state of Illinois and its communities to the best of our ability through preparedness activities that engage the whole community to address identified core capabilities in order to ensure a more prepared and resilient state and nation.


IPP Development Methodology

Through the implementation of HSEEP practices, organizations can use training and exercises to build or sustain current capability levels, identify gaps and overcome shortfalls. This is best achieved through forecasting training and exercise activities annually in IEMA-OHS's multi-year IPP.

IEMA-OHS's multi-year IPP uses a progressive approach to coordinate and plan for needed training courses and exercises based on the state of Illinois' priority Core Capabilities. A progressive training and exercise program is a series of training and exercises tied to a set of common priorities.

These training and exercises are designed to identify training and exercise activities for Illinois resulting from the priorities identified at the IPPW. Additionally, local-specific training and exercise activities are captured based on local priorities, IL-CATT assessments, and emergent needs. A more detailed explanation of this process follows below in - "Phase 1 - Capabilities Assessment."

The planning process and methodology for the annual development of the IPP is conducted in three phases: Capabilities Assessment, Prioritization, and Conduct of the annual Training and Exercise IPPW. All three phases are essential components of the State Preparedness System. A brief explanation of the three phases follows.



Phase I - Capabilities Assessment

The Capabilities Assessment provides a gap analysis, by Core Capability, for each desired outcome and capability target identified in the Illinois THIRA.

State of Illinois THIRA/SPR and Local Jurisdiction IL-CATT Process

The state and communities use the THIRA to assess risk and set capability targets that reflect their preparedness goals, answering three key questions:

- What threats and hazards can affect our community?
- If they occurred, what impacts would those threats and hazards have on our community?
- Based on those impacts, what capabilities should our community have?

The THIRA/SPR goes beyond evaluating risk, as it also identifies what communities need to do to address that risk.

By completing the THIRA process, communities can better understand what they need to prepare for and how to translate that information into action. Communities begin by identifying the threats and hazards that would most challenge their capabilities. They then provide context for those threats and hazards, developing scenarios that describe how they may affect the community. The scenarios include factors and conditions that would make

those threats and hazards especially challenging for delivering capabilities. This helps communities better understand what they need to be prepared for.

Communities then set capability targets that are specific, measurable, actionable, relevant to potential threat and hazard impacts, and time bound. Setting preparedness goals for addressing the impacts of their most challenging threats and hazards every three years helps communities to track progress over time and describe their preparedness in specific, measurable terms.

Through the THIRA/SPR process the state of Illinois has identified Earthquake, Improvised Nuclear Attack, Pandemic-Human and Cyber Attack as the greatest threats and hazards and applied these across all 32 Core Capabilities to develop context descriptions, capability targets and has identified gaps in five different areas: Planning, Equipment, Organization, Training and Exercise (POETE).


The Capabilities Assessment is conducted through a FEMA-defined 1-5 assessment rating for each POETE element of each Core Capability; a set of standardized questions to guide the rating process; and a brief statement of gaps that must be filled to raise an element to a higher level of capability, the rationale for jurisdictional IPP planning, training and exercise priorities is based on multiple sources: self-assessment through the state THIRA and SPR; local jurisdiction IL-CATT assessments; Exercise/Actual Event AAR/IP Corrective Actions; Senior Leader Priorities; and Regulatory/Statutory Requirements. Each of the eight IEMA-OHS Regions, the Urban Area Security Initiative region, and each state agency involved in Illinois emergency preparedness is required to complete an assessment.

The compiled and analyzed data from the Capabilities Assessment is then used as one statewide assessment (snapshot of preparedness) for Illinois following the review of the Training and Exercise Program Committee.

Core Capabilities Assessment

The combined Statewide Capability Assessment is based on the information contained in the state of Illinois THIRA/SPR and from information in the IL-CATT document submitted by the local accredited EMA jurisdictions from all 8 IEMA-OHS Regions.

Phase II - Prioritization

After the Capabilities Assessment is completed, the next phase in the development of the IPP is determining the priority of capabilities for the state of Illinois. This list shapes the development of the next multi-year planning, training, and exercise strategy. This strategy is reviewed by committee and implemented the following year. State priorities are grounded in FEMA's 32 Core Capabilities definitions and HSEEP consistent. Core Capabilities are prioritized each year simply because the state of Illinois cannot make every capability a priority; therefore, input from state and local stakeholders is used to determine where to prioritize efforts statewide.

As part of the capability prioritization, regional coordinators are expected to convene with their stakeholders in their IEMA-OHS Regions (including counties, cities, and private sector) to prioritize which capabilities their Region assesses as either gaps that must be improved or capabilities that must be built or sustained.

The prioritization data is synthesized for commonalities, by entity (i.e., local jurisdiction, county, etc.). Additionally, all stakeholders must ensure that their primary missions are adequately addressed in the prioritization process.

NOTE: To do an effective statewide prioritization of the Core Capabilities, a thorough Capabilities Assessment must be completed to formulate a baseline. Regional Coordinators and State Agencies must have the baseline status of capabilities in their jurisdiction and how those capabilities affect how prepared we are as a state, to determine the priority focus areas for the following year.

Phase III – Conduct of Annual Training and Exercise IPPW

The purpose of the annual IEMA-OHS Training and Exercise IPPW is to develop a multi-year IPP for the state of Illinois and accredited emergency management programs from Illinois counties and municipalities. The IPP identifies an entity's priorities as articulated in the entity's strategy and identifies the capabilities that are most relevant to achieving those priorities identified in Phase II. It then outlines a forecast of training and exercises that an entity will undertake, to build, improve, validate, or sustain its capabilities.

Prior to the annual IPPW, the Regional Coordinators and State Agency Representatives will assess the capability gaps and chosen priorities for their region. The IEMA-OHS Training and Exercise Section offers to assist each region with a list of potential training and exercise opportunities to address the prioritized capability. Regional and State Agency Representatives are then expected to review, modify, or approve the list of training and exercise opportunities that will serve as the basis for the multi-year training and exercise forecast.

Exercise Levels

Four exercise levels are considered in the state of Illinois Integrated Preparedness Plan – state, a state agency, local, and federal/national. The state conducts exercise activities in various forms, including workshops, seminars, tabletops, functional and full-scale.

Local

Exercises conducted at or by a local unit of government or agency. 29 IL Administrative Code Part 301 requires exercise participation for accredited jurisdictions. A wide variety of topics or scenarios frame these exercises. Local exercises may involve one or more partner, state, or federal organizations.

State Agency

Exercises conducted by individual state agencies. Regulatory requirements, standards, or specific functional areas generally drive these exercises. State agency exercises may involve one or more partner, state, or federal organizations.

State

Exercises conducted at the state level, through the State Emergency Operations Center (SEOC), are used to validate all or part of the Illinois Emergency Operations Plan (IEOP) and supportive doctrine. Each of the various forms of exercises is used and are based on the prioritization of identified capabilities gaps.

Federal/National

Exercises supported, sponsored, or conducted by a federal agency or organization. These exercises may include one or more state agencies, units of government, or private sector organizations.

Building Block Approach

The IEMA-OHS Training and Exercise Program practices and strongly encourages a progressive approach to exercise development which includes a series of progressive exercises, with each exercise building upon the previous one. Each exercise within the series is linked to a common set of program priorities and designed to test associated capabilities. Further, by including a training component in the planning process and maintaining awareness of other preparedness activities within the IPP, jurisdictions/ organizations can more completely address known gaps and priority areas prior to exercising capabilities.

Training Priorities

The training program is guided by the following priorities:

- Maintain a robust training program that incorporates activities and training priorities of all existing training programs within the state, including state, jurisdictional, state agency, private sector, and all other state partner agencies;
- Support training that enhances State EOC preparedness and aligns with the state of Illinois' priority capabilities;
- Provide training assistance and support to local jurisdictions, state agencies, private sector, non-governmental and tribal partners through the engagement of federal and consortium training programs.

Exercise Priorities

The exercise program is guided by the following priorities:

- Maintain a robust exercise program that incorporates activities and exercise priorities of all existing exercise programs within the state, including state, jurisdictional, state agency, private sector, and all other state partner agencies;
- Support exercises that enhance State EOC preparedness and align with the state of Illinois priority capabilities;
- Provide exercise technical assistance and support to local jurisdictions, state agencies, private sector, non-governmental and tribal partners.

Needs Assessment

For the purposes of developing the Integrated Preparedness Plan, workshops serve as a primary form of needs assessment. They assist jurisdictions in determining capability gaps to inform the training and exercise schedule.

Integrated Preparedness Plan Workshops

The state of Illinois will conduct two rounds of Integrated Preparedness Planning Workshop (IPPWs) to gather proposed training and exercise schedules and events from local, state, federal and private sector partners, that address jurisdictional capability gaps and form a comprehensive view of the training and exercise landscape within Illinois.

Prior to the local jurisdiction IPPW, the Training and Exercise Section with the assistance of the Regional Offices distributes a training and exercise planning worksheet to its stakeholders. Stakeholders use the spreadsheet to enter their training and exercise needs over a multi-year period and should address their capability gaps and established priorities. The planning worksheets help to identify assistance needed from IEMA-OHS for coordinating and conducting training courses, give predictability in scheduling events over a multi-year period and summarize training and exercise events that support workplans associated with grants.

IPPW Schedule

IPPWs will be conducted in September and April-May of each year. The September workshop will be used to update and validate each organization's proposed schedule of activities. During the April-May workshops, local and state agencies will provide known and/or scheduled activities. Combined, these workshops allow for the development and submission of Illinois' Integrated Preparedness Plan (IPP) to the Federal Emergency Management Agency (FEMA) by January 31st annually.

IPP Review and Revision

All organizations may (and are expected to) adjust their training and exercise schedule according to jurisdictional priorities regarding jurisdictions' capability building, as well as unforeseen threat and hazard events throughout the calendar year. To the extent possible, Illinois' IPP will be updated and disseminated to all stakeholders.

Revisions to schedules, events or activities should be provided to an IEMA-OHS Regional Coordinator or the IEMA-OHS Training and Exercise Program Manager.

Local Jurisdiction Check-Out Procedure

All accredited jurisdictions will follow a consistent check-out procedure with IEMA-OHS prior to EMPG approval. Local accredited jurisdictions should identify how they are addressing identified core capability gaps in the jurisdictions IL-CATT and any grant requirements for training and exercise deliverables.

Local jurisdictions and IEMA-OHS staff will meet to review the jurisdictions' IPP and assist the local jurisdictions in completing an appropriate IPP. It is understood that not all jurisdictions will be working on the same core capability gap at a given time but should be focusing on addressing the gaps identified in their local IL-CATT submissions. IEMA-OHS Training and Exercise staff will be available to assist local jurisdictions in obtaining appropriate training courses and assisting in the exercise process.
